Minutes of the Meeting held on Monday 4th June 2007

1) Open Forum

a) Police Update – attended by PC A Scarisbrick.

PC Scarisbrick informed the meeting that, during the last month, there had been a number of incidents of vandalism and alcohol had been confiscated and thrown away. There had been one incident of graffiti in the Memorial gardens. The park is now being patrolled on a regular basis.

He reported that he had not been able to identify the persons using quad bikes on Bush lane, but he has asked the residents to contact him if anyone is seen.

Councillor Mrs. Whitehead reported that there have been a number of incidents on the Lower lane estate, over the last 3 months, but the Police have previously informed the meeting that no incidents have been logged. PC Scarisbrick stated that he was aware of the incidents and investigations were ongoing.

Councillor Threlfall asked for an update on the progress being made to re-open the Police station. PC Scarisbrick indicated that the work was still being progressed.

b) Public participation

A member of the public indicated that football was still being played in the road on The Mede and asked when the "No football" signs would be erected. County Councillor Whittle stated that the LCC was looking for the right sign to be displayed and he would progress this with Karen Gallagher.

Councillor Mrs. Delany reported that an advertising board, at 91, Kirkham road, was protruding out into the pavement and was causing an obstruction. It was agreed that this was a commercial sign on domestic property and the Clerk should write to the Enforcement officer, at Fylde Borough Council.

The Chairman reported that she had attended the "litter picking" fund raising event, organized by the Younger Years committee and all the children had worked hard making the village look tidier. It was agreed that a letter of thanks should be sent to the committee.

2) **Declaration of interest**

There were no declarations of interest.

3) Declaration of Gifts and Hospitality.

There were no gifts or hospitality to declare.

4) To read and approve the minutes of:-

a) The Parish Council meeting held on Thursday 10th May 2007

Resolved: That these be affirmed as a true record and signed by the Chairman,

Proposed by Councillor L Rigby, seconded by Councillor Mrs. M Foster and unanimously accepted.

Matters arising

- **1.** Co-opted member The Clerk reported that he had received 7 applications for the Council vacancy. It was agreed that a meeting would be on Monday 11th June 2007, to interview the candidates.
- **2. Annual Report** The Clerk suggested that the Council should produce an annual report and place it in the Newsletter and on the web site. The format should be an extract of the minutes of the Annual assembly. It was agreed that an Annual report should be produced.

- **3**. **Dog Banning Order** The Clerk reported that FBC had responded to the request for assistance in setting up a dog banning order on the Bush lane playing fields. They requested that the Council writes to them indicated which of the following preferred options should be progressed:
 - a) A ban on the cricket and football pitches with access allowed to all other parts of the playing field.
 - b) A ban on the north side of the playing fields with access to the south side, but all dogs must be kept on leads.
 - c) A total ban on all parts of the playing fields.

It was agreed that the views of the Rawstorne centre and the sections using the playing fields should be sought. The Clerk agreed to write to the Rawstorne centre.

- **4. Meeting with LCC regarding road repairs** Councillor Threlfall enquired when this meeting would be arranged. Councillor Whittle stated that the LCC were awaiting the budget allocation before this meeting could be progressed
- b) The Planning meeting held on Monday 21st May 2007

Resolved: That these be affirmed as a true record and signed by the Chairman

Proposed by Councillor Mrs. S Delany, seconded by Councillor St J Greenhough and unanimously accepted.

Matters arising

Planning application - 07/0463 - Woodys Warehouse, Kirkham road – Councillor Greenhough reported that he and Councillor Mrs. Whitehead had checked the additional paperwork that had been submitted with this application. The only record of sales was in respect of farming materials, for the period between 1997 and 2000.

Resolved: That the Council object to this application because, on the information supplied with the application, there was no evidence that building materials were sold from these premises from 1997 to 2000.

Proposed by Councillor St J Greenhough, seconded by Councillor Mrs. S Delany and unanimously accepted.

5) Finance

a) Ratification of accounts approved by the Chairman of Finance and paid by Clerk – see Appendix A

Resolved: That the payments be ratified.

b) Monthly budget statements- see Appendix B. The Monthly budget statements were noted.

c) To Approve the Accounts for the Year ended 31st March 2007.

Resolved: That the Accounts for the Year ended 31st March 2007 be approved.

Proposed by Councillor Mrs. Mrs. M Foster, seconded by Councillor St J Greenhough and unanimously accepted.

d) To review the Internal Auditors report

The Clerk reported that the External auditors were asking for an explanation of any Reserves held that were in excess of two times the annual Precept amount. It was agreed that a Finance meeting should be held on 18th June 2007 to agree what action should be taken with the Reserves.

The Clerk reported that the Internal Auditor had asked for an explanation of all the items of expenditure where the Council had paid for capital equipment for a section and they had contributed to purchase. It was agreed that, in future, these purchase should be noted in the minutes.

The Clerk reported that the Cricket section had requested that the Council purchase a new roller for $\pounds 2,350$ and they will donate $\pounds 2,000$. It was agreed that this purchase should be made.

e) To approve the Audit statement of Assurance for the 2006-07 Accounts **Resolved: That the statement be approved.**
