Minutes of the Meeting held on Monday 2nd July 2007

1) Open Forum

a) Police Update – attended by PC A Scarisbrick, Inspector Darwin and Sgt. Fowler

PC Scarisbrick informed the meeting that, on Club day there had been one incident on the fair and the incident with the toilets that was reported the following morning. During the last month, there had been two incidents on the park that had been reported by the Clerk and a suicide, by hanging, on the Lower lane estate. The Police had received twenty-four calls from the public regarding anti-social behaviour by Youths and thirteen crimes, of which four were burglaries on Greenfield Park. There had been two incidents of pedal cycles being stolen and two of criminal damage.

Councillor Greenhough thanked the Police for the excellent policing of the half marathon.

Councillor Linda Burn asked the Police why they did not stop the Youths from playing ball games in Memorial gardens. She stated that this area has been set aside as an area of remembrance and villagers have expressed concerns about ball games being played here. The police responded by stating that ball games can be played in this area as there are no signs restricting their use.

Councillor Threlfall indicated that the youths congregated in this area because the seats were there and suggested that the Council might consider removing them.

Councillor Fiddler indicated that it was a sign of the times when we are considering taking away the seats that were installed for people to be able to sit and reflect on the past and cost a lot of money. He indicated that it would be a shame to have to withdraw these facilities.

Councillor Linda Burn suggested that a sign be erected to indicate that this was an area of reflection and no ball games should be played.

It was agreed to refer this matter to the Open Spaces committee.

Councillor Mrs. Whitehead suggested that the Council should publicise the cost of the work required to clean up and repair the effects of vandalism and anti-social behaviour. It was agreed that this information should be shown in the Newsletters, on the web-site and on the noticeboards.

County Councillor Whittle suggested that a Youth shelter should be provided in an area away from the Memorial gardens. He indicated that funding might be available for this type of project.

The Chairman enquired when the Police house would be occupied. Inspector Darwin indicated that work was still ongoing.

b) Public participation

A member of the public enquired when the "No Football" signs would be erected on The Mede. County Councillor Whittle stated that the LCC was still progressing this item.

Councillor Mrs. Delany reported that the dike, adjacent to Coopers farm, on Kirkham road, was being blocked by concrete and rubbish left by workmen from the Prison. It was agreed that a letter should be sent to the Governor asking for the dike to be cleaned out.

The Clerk suggested that the most practical option was a ban on the north side of the playing fields (i.e. the cricket and football pitches and the play area next to the football pitch.) and to allow dogs to be exercised on the south side, but they must be kept on leads.

It was agreed that FBC should be asked to progress this option.
