Minutes of the Parish Council Meeting held on Monday 2nd November 2009, in the Village hall.

1) To accept Apologies for Absence.

Councillor Mrs M Dowling (accident), T Threlfall (on holiday), Mrs M Foster (on holiday) It was resolved that the reason for absence should be accepted

2) Open Forum

The meeting was adjourned to receive the representations from the Police and the public.

a) Police Update – Attended by PC A Scarisbrick, PCSO B Simpson, & Sergeant D Hannan

PC Scarisbrick gave the following update:

News/Updates:

Halloween night passed without any significant issues occurring. Officers dispersed a large group of youths from Lytham Rd who were mainly from the Kirkham and Wesham area before they had the opportunity to cause any problems. Two incidents, of eggs being thrown at properties in the village, had been reported in the week running up to Halloween. Offenders for each incident have been identified and are currently being dealt with by the NHP team.

Following on from a recent burglary at a property on Lytham Rd, an offender from the Warton area has been identified and charged with the offence.

A Freckleton youth responsible for damage to a vehicle took part in a Restorative Justice conference where by the youth came face to face with the victim with Police officers present. This has had a positive effect on the youth responsible who has since been to the victims address to wash the vehicle concerned as a way of an apology as well as receiving a reprimand from the Police.

b) Public participation

Concerns were raised by a member of the public regarding the speed indicators being used on the bypass coming into the village. The police confirmed that they are there as a general deterrent warning motorists to slow down. It was noted that the speed indicator on the bypass on the way to Preston is not working. County Councillor Paul Rigby volunteered to report this. The other main concern raised by the public was speeding vehicles and juvenile nuisance in the Bush Lane area. This has been discussed various times before and it was resolved to enquire about the costs of obtaining calming measures on this road, such as sleeping policemen or a 20mph speed limit, and to pursue the issue of obtaining yellow lines on the dangerous bend. County Councillor Paul Rigby also volunteered to look into the possibility of LCC paying the costs.

The siting of the safety partnership van on Strike Lane was also discussed.

The meeting was reconvened.

3) To record Declaration of interest from members in any item to be discussed.

All Councillors declared an interest in the Rawstorne Centre

4) To read and approve the minutes of:

- d) To consider the sale of the trailer The trailer stored by the Council is surplus to requirements and no longer used. It was resolved to sell the trailer, and the Clerk will enquire as to the value of the trailer.

7) To review the arrangements for the Tree lighting & Carol service

The arrangement were discussed and reviewed. A vote of thanks were given to Councillor Greenhough and & Mrs Greenhough for donating all the food and goody bags for the children last year.

8) To consider changes to the Rawstornes Centre's constitution (Approved by the Rawstorne AGM in 2008)

It was noted that the changes cannot be adopted until the AGM. The Clerk will point out that item 6a, should be changed to read "should be aware of surrounding areas" and not "be responsible for surrounding areas"

9) To consider the request to support the campaign for "More Power for Parish & Town Councils"

It was resolved to support the campaign in principle

10) To consider what action to take regarding the infringement of the Dog Control Order

The Clerk and a member of the Council reported that they had witnessed dogs, both on and off the lead, being exercised on the Bush Lane playing fields within the exclusion area.

It was resolved to remind residents that they will be issued with a fixed penalty notice if seen contravening the new Order. It was further resolved that a notice should be placed in the Evening Gazette and the Lytham St Annes Express, in the next Newsletter and on the website
