# Finance

#### Planning

It was resolved that the Planning committee would have full delegated authority for the decisions made. In addition, that it would meet on a monthly basis.

#### **Open Spaces**

It was resolved that the Open Spaces committee would have full delegated authority for the decisions made. In addition, that it would meet on a monthly basis between March and July and again in October.

## Fabrics

It was resolved that the Fabrics committee would have full delegated authority for the decisions made. In addition, that it would meet in February and October.

#### Communications

It was resolved that this would be a "Task and Finishing" group. It was resolved that this working group would have delegated responsibility for the content, production and distribution of the Newsletter. All other recommendations made by this group would be referred to Council for ratification.

The Chairman will be represented on this committee each year. In addition, it would meet in January, April, July and October each year.

Councillor Rigby stated that he would seek legal advice from the Monitoring Officer and asked that this item be include on next month's agenda.
