Clean Neighbourhoods & Environment Act 2005 Enforcement Officer

The Parish Council are looking to employ a part time Enforcement Officer to ensure that the recently introduced Dog Control Order, for the Bush lane playing fileds, is observed.

The candidate should live/work close to the Bush lane Playing fields and be able to check the area at irregular times of the day. He/She should be tactful and be fair and firm when dealing with the issue of a Fixed Penalty Notice. The remuneration will be an annual fixed sum retainer with no fixed working pattern. He/she will be expected to monitor the playing fields regularly, preferably as part of their daily activities. Full training will be given before commencement of the post.

Parish Council's Complaints procedure.

The Parish Council would like to draw the Parishioners' attention to the Council's code of Practice for dealing with Complaints.

Part one of the Code of Practice requests that any complaint is first referred to the Clerk to see if it can be resolved by less formal measures. This would also ensure that all the facts are verified before a more formal complaint is made.

The Council's welcomes constructive criticism, but would ask anyone seeking to progress a complaint, about the conduct of the Council members, to first discuss it with the Clerk, or the
