### 1) To accept Apologies for Absence.

### 2) Open Forum

### b) Public participation

Cllr Threlfall reported that the gully's in and around Freckleton are not being cleaned which is causing considerable flooding. C Cllr Roberts reported that LCC don't have their own equipment but they were in the process of sourcing and purchasing their own equipment. He also pointed Cllr Threlfall in the direction of Warren Goldsworthy (LCC Highways).

A member of the Public asked did we know how many times the bar code had been scanned for the heritage map. Pete the webmaster for FPC will have a look to see if he could see how many times the heritage map had been accessed. He said if he couldn't get this information he could set something up to monitor it going forward. The member of the public also asked if a bar code could be set up at the shops for past and present information. The clerk will have a look.

Other issues brought up by the public: Poor parking in the village. Cars parking on the pavement which didn't allow wheel chairs and push chairs to get past. Also speeding on Bunker St. It was agreed to put this on the next agenda.

Angus said we were doing all the right things to help our case. One of the next things on the agenda is to visit the site including the access roads. Keith also stated that there had been a new set of costing been presented on the alternative route which came in at £903m less, this included upgrading Stanna.

### 9) To consider the quotes for draining the Bush Lane allotments

The clerk has received a verbal quote of £42000 but nothing in writing despite the clerk's request made by email for the quote to be sent in writing. It was requested by several councillors that the clerk contact the company that quoted last year for an updated quote.

## 10) To consider a request from the C of E school to block off a parking bay at the entrance to the school.
